

Operation Carolina NordicTrack Giveaway

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility

The Operation Carolina NordicTrack Commercial 2450 Giveaway (the “**Sweepstakes**”) is open only to legal residents of the United States and the District of Columbia (excluding Alaska, Hawaii, and all U.S. territories and possessions), who are at least 18 years old (or the legal age of majority in their state of primary residence, whichever is greater) at the time of entry. Void where prohibited. Proof of residency and age may be required. Employees and directors of Operation WarriorFit (“**Sponsor**”), iFIT Inc. (“**Prize Provider**”), and their respective subsidiaries, divisions, affiliates, and advertising or promotional agencies or individuals involved with the design, production, execution, or distribution of the Sweepstakes and the immediate family and household members of such individuals, are not eligible to enter or win. “**Immediate family members**” means parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, regardless of where they live. “**Household members**” means people who share the same residence at least three months a year, whether related or not. In order to enter the Sweepstakes or receive the Prize, you must fully comply with the Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of the Sponsor, whose decisions are binding and final in all respects relating to this Sweepstakes.

2. Sponsor

The Sweepstakes Sponsor is Operation WarriorFit, 80 Twain Trail, Fletcher, North Carolina 28732, a registered 501(c)(3) nonprofit organization incorporated in North Carolina, Federal ID: 33-2673785. Sponsor is solely responsible for the administration of the sweepstakes.

3. Timing

The Sweepstakes began when donor registration opened for Operation Carolina on August 10th 2026 (the “**Event**”) and ends October 7th, 2026 at 4 p.m. Eastern Time (“**ET**”) (“**Sweepstakes Period**”). Sponsor or its designee is the official timekeeper for this Sweepstakes. The Sweepstakes is governed by these Official Rules and is subject to all applicable federal, state, and local laws.

4. How to Enter

To enter, a donor may either (a) make a voluntary contribution to the Event at <https://akqgncfs.donorsupport.co/page/FUNBPHHJZGB> during the Sweepstakes Period, or (b) enter by using the free Mail-In Entry method described below. A donation is voluntary and is not required to enter or win. Entries received through either method of entry will have an equal chance of winning.

Limit of one (1) entry per person. Entrants may only use one (1) email address to enter the Sweepstakes. You are not permitted to share the same email address with another entrant. Use of any automated system or artificial intelligence app or software to enter is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected entries all of which will be ineligible to win the Prize. In the event of a dispute as to the identity of any entrant, the authorized account holder of the email address used to enter will be deemed to be the entrant. The “**authorized account holder**” is the natural person assigned an email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder to be awarded the Prize.

5. Mail-In Entry

To enter without submitting a donation, entrants may, on an index card, hand-write “Operation Carolina Sweepstakes”, and entrant’s full name, complete address, and email address in English, and mail the index card via first-class mail in a properly stamped address to: Operation WarriorFit, 80 Twain Trail, Fletcher, North Carolina 28732 (a “**Mail-in Entry**”). Mail-in Entries must be received at the above address by October 7th, 2026 at 4 p.m. ET to be eligible. Limit one (1) entry per stamped outer envelope during the Sweepstakes. All Mail-in Entries must be mailed in separately. Sponsor is not responsible for late, lost, damaged, illegible, or postage-due mail. Only one (1) Mail-in Entry shall be valid during the Sweepstakes. Sending multiple Mail-in Entries will not increase entrant’s chances of winning.

6. Winner Determination

After the Sweepstakes Period, the Sponsor will select one (1) eligible entry for the Prize described below in a random drawing of all valid and eligible entries received. Odds of winning depend on the number of eligible entries received during the Sweepstakes Period. The potential Sweepstakes winner will be announced at the completion of Operation Carolina on October 7, 2026, and notified using the email address provided with the entry. Failure by the potential Sweepstakes winner to respond to the initial verification email within five (5) days of notification will result in disqualification and Sponsor will select an alternate potential Sweepstakes winner in the same manner. Limit of one (1) Prize per person.

7. Verification of Potential Winner

POTENTIAL SWEEPSTAKES WINNER IS SUBJECT TO VERIFICATION BY SPONSOR. SPONSOR DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE ADMINISTRATION, OPERATION, SELECTION OF THE WINNER, AND OTHER MATTERS RELATED TO THE SWEEPSTAKES. Potential Sweepstakes winner may be required to complete and return an Affidavit of Eligibility, Release of Liability, and Publicity Release (where permitted by law) (collectively, the “**Affidavit**”) by the date specified by Sponsor, or an alternate potential Sweepstakes winner may be selected. In the event: (a) potential Sweepstakes winner cannot be reached for whatever reason after a reasonable effort or the potential Sweepstakes winner notification or Affidavit is returned as undeliverable; (b) potential Sweepstakes winner declines or cannot accept, receive, or use the Prize for any

reason; (c) of noncompliance with the above or within any of the aforesaid time periods; (d) potential Sweepstakes winner is found to be ineligible to enter the Sweepstakes or receive the Prize; (e) potential Sweepstakes winner cannot or does not comply with the Official Rules; or (f) potential Sweepstakes winner fails to fulfill the Affidavit-related obligations, the potential Sweepstakes winner will be disqualified from the Sweepstakes and an alternate potential Sweepstakes winner may be selected, at Sponsor's sole discretion, from among the other eligible entries received. Sponsor reserves the right to modify the notification and Affidavit procedures in connection with the selection of alternate potential Sweepstakes winner, if any.

8. Prize

There will be one (1) Sweepstakes winner. The Sweepstakes winner will receive one (1) NordicTrack Commercial 2450 Treadmill ("**Prize**") (approximate retail value: \$2,900). Prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the listed Prize for one of comparable or greater value for any reason. Prize Provider will provide standard delivery to the Sweepstakes winner's primary residence according to Prize Provider's Shipping Policy. The Sweepstakes winner must reside in a location within the continental United States that is serviceable by Prize Provider's standard delivery network. Additional delivery charges outside standard delivery areas are the responsibility of winner unless Sponsor elects otherwise. Free account and agreement to Prize Provider's Terms of Use are required to activate and use the Prize. Paid iFIT Pro subscription (not included) and WiFi required to access full content and features of the Prize. The Sweepstakes winner is responsible for all taxes and fees associated with Prize receipt and/or use. All federal, state, and local tax liabilities, as well as any other costs and expenses not specified herein as being awarded are the sole responsibility of the Sweepstakes winner. The Prize will be awarded only if the potential Sweepstakes winner fully complies with these Official Rules.

9. Entry Conditions and Release

Each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) indemnify, release, and hold harmless the Sponsor, Prize Provider, and their respective parent, subsidiary, and affiliated companies, and any other person and organization responsible for sponsoring, fulfilling, administering, advertising, or promoting the Sweepstakes, and all of their respective past and present officers, directors, employees, agents, and representatives (collectively, the "**Released Parties**") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye, or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Sweepstakes and/or Event, acceptance, possession, attendance at, defect in, delivery of, inability to use, use or misuse of the Prize, and/or the broadcast, exploitation, or use of entry. The Sweepstakes winner acknowledges that the Prize is awarded as-is without warranty of any kind. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be (a) tampering with or disrupting the fairness of the entry process or the operation of the Sweepstakes, or with any website promoting the Sweepstakes; (b)

acting in violation of the Official Rules; or (c) entering or attempting to enter the Sweepstakes multiple times through the use of multiple email addresses or the use of any robotic or automated devices or artificial intelligence apps or software to submit entries. If Sponsor determines, in its sole discretion, that technical difficulties, tampering, fraud, unfairness, or unforeseen events compromised the integrity or viability of the Sweepstakes, Sponsor reserves the right to void the entries at issue, and/or terminate the relevant portion of the Sweepstakes, including the entire Sweepstakes, and/or modify the Sweepstakes and/or award the prize from all eligible entries received as of the termination date.

10. Limitation of Liability

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or utilized in the Sweepstakes; (b) any late, lost, misrouted, garbled, distorted, or damaged transmissions or entries; (c) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (d) unauthorized human intervention in any part of the entry process or the Sweepstakes; (e) technical or human error in the administration of the Sweepstakes or the processing of registrations; (f) any disruptions, injuries, losses, or damages caused by events beyond the control of Sponsor or by non-authorized human intervention; or (g) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, Event, or receipt or use or misuse of the Prize. If for any reason an entrant's registration is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Sweepstakes. No more than the stated number of prizes will be awarded.

11. Publicity

Except where prohibited or restricted by law, the Sweepstakes winner's acceptance of the Prize constitutes the winner's agreement and consent for Sponsor, Prize Provider, and any of their respective designees to use and/or publish winner's full name, city and state of residence, photos or other likenesses, pictures, portraits, video, voice, testimonials, biographical information (in whole or in part), and/or statements made by winner regarding the Sweepstakes, Event, Sponsor, or Prize Provider, worldwide and in perpetuity for any and all purposes, including, but not limited to, advertising, trade and/or promotion on behalf of Sponsor or Prize Provider, in any and all forms of media, now known or hereafter devised, including, but not limited to, print, TV, radio, electronic, cable, or World Wide Web, without further limitation, restriction, compensation, notice, review, or approval.

12. Disputes

Entrant agrees that: (a) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes will be resolved individually, without resort to any form of class action; (b) any and all disputes, claims, and causes of action arising out of or connected with this Sweepstakes, or any prizes awarded, will be resolved exclusively by the United States District Court for the District of Utah or the appropriate Utah state court; (c) any and all claims, judgments, and awards will be limited to actual out-of-pocket costs incurred, including costs associated with entering this

Sweepstakes, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrant, Sponsor, and/or Prize Provider in connection with the Sweepstakes, will be governed by, and construed in accordance with, the laws of the State of Utah, without giving effect to any choice of law or conflict of law rules (whether of the State of Utah or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Utah.
